

**2006 ANNUAL MEETING MINUTES
SPRINGVALE TOWNSHIP
MARCH 14TH, 2006**

New Pathways sent a letter asking for a donation. No one was present for representation of New Pathways. Jack Durham made a motion to donate \$0.00. No one seconded. Nancy Clay made a motion to donate \$600.00 to New Pathways with a letter requesting representation and to send a copy of financial report. Kevin Schluck seconded the motion. Motion carried. Kim Shaffer was present to request a donation for Family Pathways. Peter Clay made a motion to donate \$1000.00. to Fmaily Pathways, Gary Moss seconded the motion. Motion carried. No one was present from the Refuge but a letter was sent requesting a donation. Jack Durham made a motion to donate \$0.00 to the Refuge. Peter Clay seconded the motion. Motion carried. Gary Moss made a motion to send a letter to the Refuge requesting representation and explaining withdrawal of a donation this year. Kevin Schluck seconded the motion. Motion carried. Steve Nelson the Oak wilt coordinator in Isanti County requested a donation with a letter. Steve Nelson was not present. Keith Schluck made a motion to donate \$500.00 to Oak Wilt seconded by Emery Sumption. Motion carried. The Seven County Senior Federation sent a letter requesting a donation. No one was present for the senior federation. Jack Durham made a motion to donate \$0.00 to the senior federation seconded by Dick Coleman. Motion carried.

Bill Friedland gave a 2005 road report. Roger McNear gave a Parks and Recreation report.

The residents set there 2007 Levies with some discussion. Peter Clay made a motion to set the 2007 General Fund at \$40,800.00 seconded by Jack Durham. Motion carried. Peter Clay made a motion to set the 2007 Road and Bridge Fund at \$178,500.00 seconded by Gary Moss. Motion carried. Mike Hansen was present to discuss Dalbo Fire Department. Roger McNear read Cambridge Fire Department information. Peter Clay made a motion to set the 2007 Fire Fund at \$35,000.00 seconded by Jack Durham. Motion carried. Clay made a motion to approve up to \$1,500.00 for 2007 Youth Community Education. Bill Friedland seconded the motion. Motion carried. Emery Sumption made a motion to set 2007 Gopher Bounty at \$1.00 per pair of front feet. Jack Durham seconded the motion. Motion carried.

Roger McNear read the results of the 2006 Annual Election. There were a total of 31 voters. For Supervisor, 28 votes for Bill Friedland and 3 were scattered. For Clerk, 31 votes for Michelle Kleven. For Treasurer, 15 votes for Sherry Clay and 16 write in votes for Marjorie Jendro.

Town response to newsletter is good. Please continue annually. Kevin Schluck and Gary Moss requested to research a town website. Springvale Township clean up day is scheduled for May 6th, 2006. Gary Moss requested the board take back to their monthly meetings to request Isanti County to not vary their zoning ordinance for race tracks and to be put on the April agenda.

Bill Friedland made a motion to set the next Annual meeting for March 13th, 2007 at 8:15 p.m. Emery Sumption seconded the motion. Motion carried. Roger McNear made a motion to adjourn the 2006 Annual meeting at 10:11 p.m. Seconded by Emery Sumption. Motion carried.
