COMMENTS FROM FLOOR

Resident voiced question about future plans to pave Artesian Lane and Trails End. Supervisor Whipp stated this is still being considered but will require some updates to sewer manhole covers including extensions that will need to be coordinated with future paving project.

Resident reported that Trails End had no dust control last year. Per Supervisor Whipp dust control was applied on Trails End one time during the summer. Lignin was not available so product was applied one time only.

Question about natural gas roll out in Springvale Township, Supervisor Whipp has not heard anything from DTE Energy since December 2018 public meeting held at Springvale Township Hall.

Concerns voiced about the safety of Wildwood Road near dip even though a warning sign is posted. There are two big dips on the curve which create a road safety hazard.
