## **▶** Loan Agreement with Berry Creek Home Owners Association

Emmet County Road Commission (ECRC) has completed the majority of Berry Creek Road paving project. Culverts still need to be completed.

Springvale Township will loan money from the Springvale Township Improvement Fund to Berry Creek Home Owners Association to pay ECRC for the Berry Creek Road pavement project. A representative of the Berry Creek Home Owners Association, Ronald Melchert, has signed a Site Development Loan Agreement stating that

members of the Berry Creek Home Owners Association will repay Springvale Township for this loan over a 14 year period at 3% interest.

Treasurer, Dawn DeRue, made a motion to accept the Site Development Loan Agreement signed by Berry Creek Home Owners Association representative, Ronald Melchert. Trustee, Becky Fettig, supported the motion. Board unanimously approved.
