Maple Tree: The Road Commission has over-ruled the township and the maple tree on Heaton Road will be removed.

Roy Road -Ellsworth Rd. Discussion: Randy is chairing this community discussion. There is a set of documentation paperwork submitted to the Board. Randy presented the basic synopsis, verbally. Financing was discussed openly for the attendees. Mrs. Goetz made a presentation from the Roy Road residents' perspective. The use of the road by the school busses is a critical piece of this decision. She also emphasized that area residents use the road for recreational vehicles. Pat

McCune, Kyle Ulrich, Becky Fettig, Randy McCune address several of the issues. Mark Adkins, resident of Roy Road, echoed concerns expressed previously. John and Becky Bruinslot also expressed support for completing Roy Road.

DeKevin Thornton expressed concern for contributing finances to Ellsworth Road as it is an Emmet County designated road. Randy requests a motion to be created and each road voted on separately. Pat McCune moved for completion of Roy Road in 2024, Dawn DeRue seconded.
