Supervisor Recap of 2024:

Hope all is well with the Springvale Township Family. How quickly the 2024 year has come and gone! The following bullet points will summarize some of the accomplishments within our Township this year:

- In partnership with Emmet County Road Commission (ECRC), we completed the paving of South Ellsworth Road—Mitchell Road to Pickerel Lake Road.
- Finalization has occurred for the long-term quest to purchase the HME firetruck to replace a 1980's pumper truck. With the foresight of current and previous Board Members and the past supervisor, Tom Whipp, the board has been able to earmark money through our Township Improvement Fund and other General Fund accounts, CD's, and grants to invest in a new truck. We are grateful for the careful financial planning allowing Springvale Township to pay up front the cost of this vehicle.
- This fall, the Board agreed to again partner with ECRC to start a partial paving on Maxwell Road for summer 2025. In addition, we approved a small paving project at the junction of North Ellsworth and Artesian Roads near the boat launch.
- This fall we had the town hall facility repainted to deal with weathering issues on its exterior.
- Currently, we are addressing an important facet of our township's history. Our two cemeteries have an ongoing need to update missing burial records. We are reviewing the written records, names on all of the tombstones, and looking at the ground-penetrating radar mapping data. If by chance you have knowledge of family, friends, or acquaintance that are buried with no identifying tombstones, we would like to know. Sometimes the only information Springvale Township receives is the burial date or cremation date without any birth or death dates. To establish accurate cemetery records this information is vital. - Also, please visit Springvale's "hidden jewel", Springvale Township Park, which is located on Township Park Road. This year we have revamped the park with a new gravel parking area, new grass and tree removal for new tables and benches, and also a canoe/kayak launch is available. A special thank you to the Petoskey-Harbor Springs Area Community Foundation for your generous grant making this possible.

In closing, I would like to make a heart-felt thank you to all the folks who make Springvale Township such a "treasure":

Tax bills are sent out every July 1st and December 1st. If you do not receive your tax bills within these months, please contact me. Summer taxes are due September 15th 2024, and winter taxes are due February 16th2025. On March 1st, all unpaid taxes need to be paid to the Emmet County Treasurer.

Please make out your <u>tax payment check for the exact amount owed</u>. If paying by cash, the <u>exact</u> amount can only be collected. When paying after the due date, please call Dawn DeRue; Treasurer at 231-347-3077 or email her for exact total due. Please include your <u>phone number</u> on your check. If you qualify for a tax deferral, applications are available.

Also, if you would like a receipt, please include a self-addressed and stamped envelope with your payment. A **drop box** is located near the mailbox at the hall for your convenience.

Don't forget to use the **recycle** stations at the back of the Township Hall to help keep our township clean. Pick up your <u>free voucher</u> for larger items to go to the Transfer Station. Please <u>NO</u> household garbage or large items that do not fit in the recycle receptacle. This area is being monitored by cameras. Emmet County Recycling Center phone # is **348-0640**.
