Business Recycling Survey 2025

Since 2012, Emmet County Recycling has collected recycling data from local businesses to measure materials recycled **outside our system**—via corporate back-hauls, internal programs, third-party haulers, or mail in options.

These numbers matter: One local business reported recycling 110,000+ pounds in a single year!

We invite you to share your 2024 recycling and diversion data, whether you recycle with us or another service. These numbers will help to calculate the total landfill diversion rate for Emmet County.

Your information is kept confidential and secure. Our goal: complete data collection by **December 1.**

Residential Recycling Survey 2025

Michigan recently passed new recycling laws that require all 83 counties to update their Materials Management Plans (MMP). One of the key goals is to increase the state's recycling rate from 25% to 30% by 2029.

- Extend multifamily recycling services in existing curbside communities
- Develop ordinance or update planning & zoning requirements for new site developments to include space for multifamily recycling

- Establish three additional drop off sites across the county
- Upgrade processing facilities to meet the increase in material volumes and material types based on the new goals
